



SSAC Update Report – February 2019

The SSAC provides independent advice, through its Chair, to the Chief Scientific Adviser (CSA) for Scotland, to inform policy development and delivery across all areas of the Scottish Government's work. It typically develops advice on a medium- to long-term basis, advising on developments in science and technology and their implications for policy and identifying potential future opportunities and threats.

Chaired by Professor Paul Boyle, the SSAC currently has 11 other members, including the Scottish Government's Chief Scientific Advisers, all of whom are ex-officio members: Chief Scientific Adviser (CSA) for Scotland Professor Sheila Rowan, Professor David Crossman, the Chief Scientist (Health) and Professor Andrew Millar, CSA Environment, Natural Resources and Agriculture.

The SSAC issues a short report following each quarterly meeting to provide an update on its latest workstreams and areas of interest. The SSAC held its last meeting at Dynamic Earth, Edinburgh on 23 January 2019.

SSAC WORKSTREAMS

- ✚ The SSAC report 'A Metrics-Based Assessment of Scotland's Science Landscape (2007-16)', commissioned from Elsevier was launched at a reception in Edinburgh on January. The report examines Scotland's science strengths, and places Scotland's research performance in an international context. It includes comparisons with the other UK nations and selected EU and non-EU countries of similar size and research capability. - ✚ The SSAC's report 'Informing the Future of Human Genomic Medicine' (commissioned by the Chief Scientist (Health) Office) was published on 18 February. The report provides an overview of the current capabilities in Scotland, and compares developments elsewhere in the UK and internationally.
